The REAL Issue

Nova Scotia has a vibrant and robust health research community. At the NSHRF, we not only work to support the health research happening in our province, we also promote that research to the rest of Canada and the world.

I recently signed off on our 2011-12 Annual Report (to be released later this fall) and was once again reminded of the great research happening in our province. The 2011-12 Annual Report highlights the work of the past fiscal year, but the Nova Scotia health research community has always hit above its weight. The *Measuring Nova Scotia's Results in Health Research – 2009 Updated Report* demonstrates this. Below are a few facts from the report that speak to the great research taking place in our own back yard:

- Population Health is an area of research strength for Nova Scotia.
- Nova Scotia health researchers published above the national average for all three time periods examined (1996-99, 2000-03 and 2004-07).
- Health research in the province contributes to:
 - 673 person years of employment;
 - \$1.9 million annually for provincial revenues; and
 - \$25.1 million to Nova Scotia's GDP.
- From 2000 – 2009, the value of CIHR grants increased from \$7.7 million to \$19.7 million.

The success of the province's health research community not only comes from those conducting the research and those supporting it, it also comes from the communities' spirit. It was great to see the way the community came together to feedback to the Canadian Institutes of Health Research's open reform this year. I am also always excited to see the collaboration that exists between the research institutes in Nova Scotia. This community spirit is key to Nova Scotia's successes.

I also have to acknowledge the commitment of our Board and Research Advisory Committee (RAC). Their unwavering guidance has helped us provide support to the province for over ten years. This is something we have valued and look forward to seeing many more successes for our small province.

Congratulations to the 2012-13 Establishment and Development/Innovative Grant Funded Applicants

The lists of funded applicants for the 2012-13 Establishment and Development/Innovative Grants are now available on our [website](#). The [Establishment Grants](#) are intended to assist in building research capacity and to provide initial support for new health researchers in Nova Scotia over a 1-3 year period. The [Development/Innovative Grants](#) are intended to provide funding for Nova Scotia health research initiatives that will strengthen a grant submission to a peer reviewed provincial, national or international health research competition.

Regional Partnership Program Funding Opportunity

The [Regional Partnership Program](#) (RPP) supports applications that are judged to be of high scientific merit through the Canadian Institutes of Health Research (CIHR) peer review scoring of 3.5 and above, but are beyond the funding capacity of the CIHR's base budget in their regular competitions. At this time, the only funding tool eligible under this program is CIHR's bi-annual "Operating Grant". Application information is available on CIHR's [website](#).

Our specific RPP requirements can be found on our [website](#). Our deadline for the next intake of applications is five days after CIHR's deadline. The next intake under the RPP will be September 2012. The CIHR deadline is **September 17, 2012**. Applicants must electronically submit the required documents to us by **September 24, 2012 11:59 p.m.** Any questions can be directed to [Jennifer McNutt, Manger, Research Programs](#).

Partnerships for Health System Improvement (PHSI) Funding Opportunity

The intent of the [Partner for Health System Improvement \(PHSI\) program](#) is to strengthen Canada's healthcare system through collaborative, applied and policy-relevant research. PHSI is Canada's premier health services and policy research funding opportunity — and with its strong emphasis on partnerships and knowledge translation, it is also a major resource for managers and policy makers who want relevant research to inform their decision-making. PHSI funds teams of decision makers and researchers to conduct applied health services and policy research.

We have a collaborative agreement with CIHR to be a competition partner on this funding opportunity. This means that we will consider financially supporting applications in which Nova Scotia researchers and/or decision makers figure prominently.

In Profile: Nova Scotia Research

We first funded Chris McMaster, PhD, Dalhousie University in 2009 and have seen his research have great success over the years. Chris is project leader of [The IGNITE Project](#), which is the culmination of enormous efforts by a large collection of people with a vision to reduce the impacts of orphan diseases through strategic research and development. Orphan diseases are rare disorders that affect less than one in 2,000 people in Canada or less than 200,000 individuals in the United States. But, collectively, the 7,000 known orphan diseases impact 1 in 12 Canadians, causing physical and mental hardship, and draining money and resources from our health care system. The IGNITE Project was funded by Genome Canada.

On June 6, 2012, Chris and his IGNITE Project co-leader, Conrad Fernandez, MD, presented the key components of The IGNITE Project and its implications for patient care. You can view the video [here](#) to learn more.

- to create a critical mass of technical and scientific expertise by establishing inflammation research teams that will unite researchers across relevant research disciplines and at least two health research themes (biomedical, clinical, population health, and health services);
- to promote research approaches to create new knowledge and ensure the effective application of research to solve important problems identified in the inflammation in chronic disease field and promote the clinical translation of research outcomes into improved patient care and health, social and economic benefits nationally and internationally;
- to provide a high-quality, multi-disciplinary training and mentoring environment.

Canadian Institutes of Health Research and Canadian Nurses Foundation Funding Opportunity
Nursing Intervention Research for Older Adults (Small Health Organizations Partnership Program).
Application deadline: October 15, 2012

CIHR, through the Small Health Organization Partnership Program (SHOPP), in partnership with the Canadian Nurses Foundation (CNF) and the CIHR Institute of Aging (IA) will provide funding for applications that are determined to be relevant to the following research priority areas described below:
Intervention research focused on improving care and quality of life for older persons and/or their caregivers.

Applications with a focus on the spectrum of care for older persons with complex needs involving dementia are encouraged.

Proposals are to include aging and/or the aged as essential elements of the research objectives, hypotheses and analyses (e.g., dynamics of aging, age-relevant models and/or aged subjects). With respect to diseases common in old age, the focus must be on the effects of the disease specifically in the elderly, rather than on diseases in a general context.
